November: Mayor issues budget instructions

November – February: Departments develop budget submissions

March – May: Mayor aligns priorities and prepares a proposed budget

May – June: Mayor releases proposed budget for Enterprise departments on May 1 and releases budget for all other departments on June 1

June – July: Board of Supervisors reviews budget, holds hearings, and makes adjustments based on priorities

August: Board adoption of final annual budget

Budget Process Overview

November – February: Departments develop budget submissions

March – May: Mayor aligns priorities and prepares a proposed budget

April 20, 2021: OCOH Committee issues recommendations to the Mayor on its investment priorities

May - June: Mayor releases proposed budget on June 1

June 15, 2021: OCOH Committee reviews Mayor's budget; possibly makes updated recommendations to Board

June – July: Board of Supervisors reviews budget, holds hearings, and makes adjustments based on priorities

August: Board adoption of final annual budget

- Tasks and purpose assigned and coordinated by the chair
- Provide updates of activities and bring motions to adopt recommendations from such activities to Regular Meetings
