#### **MEETING MINUTES**

# **Our City, Our Home Oversight Committee Meeting**

December 15, 2020 9:30 AM - 1:18 PM 3:00 PM - 5:00 PM

This meeting was held by Webex pursuant to the Governor's Executive Orders and Mayoral Emergency Proclamations suspending and modifying requirements for in-person meetings. During the Coronavirus Disease (COVID-19) emergency, the Our City, Our Home Oversight Committee (OCOH) will convene remotely until the Committee is legally authorized to meet in person.

## 1) Call to Order/Roll Call

The meeting was called to order at 9:30 am.

Committee Members Present: Member Brett Andrews (joined late), Vice Chair Julia D'Antonio, Member Jennifer Friedenbach, Member Shaun Haines, Member Julie Leadbetter, Member Lena Miller, Member Cynthia Nagendra, Member Ken Reggio, and Chair Shanell Williams.

Committee Members Absent: None.

# 2) Opportunity for the public to comment on any matters within the Committee's jurisdiction that are not on the agenda.

There was public comment from Gabriel Baldinucci, CEO of Urban Vision Alliance, a non-profit dedicated to ending street homelessness in San Francisco. Gabriel suggested to add return on investment as one of the evaluation criteria for different projects.

There was public comment from Theo Ellington, Director of Homeless Initiative and Community Development for the Salvation Army in San Francisco. Theo introduced himself and spoke on the work the organization is performing including re-imagining the use of six properties, supporting the safe sleeping site and homeless encampments through feeding, and performing services on drug and alcohol rehabilitation.

There was public comment from Rodney Fong, President and CEO of the San Francisco Chamber of Commerce. Rodney expressed his concerned about the hundreds of thousands of unemployment claims in San Francisco and want to be sure that this group does not fall into a vulnerable community to exacerbate the problems we already have.

There was public comment from Cricket Miller, who discussed the governor's 100-day challenge. A memo was provided in addition to the public comment, and is available <a href="here">here</a>.

There was public comment from Randall Scott with the Fisherman's Wharf Community Benefit District. Randall urged the Committee to setup metrics for oversight and accountability that are easily reportable and reviewable by anyone.

There was public comment from Cassandra Costello of the San Francisco Travel Association. Cassandra thanked the members for their services and expressed interest in allocating the Prop C dollars to support the most vulnerable in the city.

There was public comment from Kristin Evans, a small business owner. Kristin stated that she was one of the proponents for Prop C. Kristin expressed frustration with some of the callers based on their prior lack of support for Prop C. She thanked the Committee for their service and stated that funds should be used to house homeless neighbors.

3) Committee to discuss Department of Homelessness and Supportive Housing proposal for immediate funding needs to support homeless services and summary feedback on recommendations regarding the proposal from the Community Liaison on Urgent Needs, and possible action by the Committee in response to this item.

Jon Givner, Deputy City Attorney, provided an overview of the conflict of interest rules. Committee members will have a conflict if their organizations are going to enter contracts or contract amendments with the City as a result of an item under discussion or vote by the committee. Members who have conflicts will have to removed themselves from the discussion and recuse themselves from voting on that recommendation. Jon Givner clarified and answered questions from the members. Ben Rosenfield stated that members should err on the side on of caution since there will be many contract amendments on a regular basis coming out of the projects proposed for OCOH funding.

Gigi Whitley, Deputy Director for Administration and Finance of Homelessness and Supportive Housing (HSH) provided additional details on HSH proposal for immediate funding needs to support homeless services. Gigi Whitley answered questions from the members regarding whether other funding may be available for some immediate needs requests made to OCOH.

At the December 9, 2020 meeting of the OCOH, Member Jennifer Friedenbach, the Community Liaison on Urgent Needs, shared proposed changes to the funding request made by HSH. In advance of the December 15, 2020 meeting, the Controller's Office compiled feedback on those recommendations from members. This feedback is available <a href="here">here</a>. Member Jennifer Friedenbach explained how she updated the recommended changes to HSH's funding request based on the feedback that she received, with this updated set of recommendations available <a href="here">here</a>. Members provided additional comments and details on the proposed changes to HSH's funding request.

The Immediate Needs Liaison proposed 13 recommendations associated with HSH's funding request, as noted in the document in the prior link. The recommendations were taken out of order and grouped based on members needing to recuse themselves due to conflict and members' available time.

# Recommendations #1, #11, #12, and #13

#### **Public Comments:**

There was a public comment from Wesley [inaudible], policy member of Glide. Wesley

thanked the members for their service and commitment to Prop C, thanked the Community Liaison on Urgent Needs in engaging and gathering feedback from the community, and stated that Prop C is a people's initiative and must be spent on its intended use.

- There was a public comment from Kristin Evans, a small business owner. Kristin stated
  that she was one of the proponents for Prop C and on the Our City Our Home Coalition.
  Kristin expressed her interest to only fund phases 1 and 2 of HSH's SIP rehousing plan.
  She expressed concerns with HSH handling of the SIP hotels process. Prop C is a
  people's initiative and must be spent on its intended use including beds for our
  neighbors.
- There was a public comment from Brian Edwards from the Coalition of Homelessness.
   Brian expressed his approval to only support phases 1 and 2 of HSH's SIP rehousing plan. Brian thanked the departments for taking input from the community. Brian stated that we should not abandon people in the safe sleeping sites.
- There was a public comment from a member of the public. He stated that funds should be used on housing and not be redirected to other purposes. He stated that the City should look into other low-cost housing options.

the department to provide additional data later to justify further release of funds,
